# Highlights

- Fees for One-Time and Continuous Queries are temporarily waived
- Applies to queries on and after March 1, 2020, through May 31,
   2020
- Entities already charged will receive query credits
- Self-Query fees will NOT be waived





#### The Reason

- President Trump declared national emergency, effective March 1
- Support nationwide efforts to deploy health professionals to areas of most need during COVID-19 pandemic
- Expedite informed decision-making during pandemic about:
  - licensing
  - hiring
  - credentialing





# **Query Rules Remain Unchanged**

- Under federal law, hospitals *must* query when:
  - Individual applies for staff appointment or clinical privileges
  - Every 2 years on medical staff members and clinical privileges holders
- Other entities may query only on individuals with whom there is an existing relationship:
  - Employment or affiliation relationship (current or pending)
  - Application for clinical privileges (including temporary privileges) or medical staff appointment
  - When engaging in professional review activities
- Must be registered with the NPDB to query





### **Query Fees After March 1 Already Paid**

- Entities will be issued query credits for all queries performed from March 1, 2020, through the implementation of the waiver
- It may take several weeks for the credits to appear
- Query credits do not expire
- Refunds will NOT be issued





### **Queries Covered by Waiver**

- Fees for all Continuous Queries and One-Time Queries are waived
- No restriction on number of fees waived for any organization
- Waiver is intended to support the NPDB's registered entities in combatting the COVID-19 pandemic
- Entities may proceed with routine querying that would normally occur at this time and fees will be waived





### **Query Purpose for COVID-19**

- The NPDB added a new query purpose option in the user interface to identify COVID-19-related queries (code 'X' for software vendors)
- Fees are waived even if this option is not used





#### **End of Fee Waiver**

- Temporary waiver of fees established to support health care entities during unprecedented period of pandemic response
- The NPDB is required by statute to recover its full cost of operations and imposes query fees for this purpose
- We currently plan to end the query fee waiver after May 31, 2020

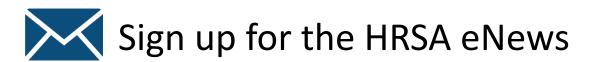
